#### What To Bring:

Photo Identification  
Social Security Cards and birthdates for you, spouse and all dependents.  
Wage and earning statements from ALL employers or sources (W-2, 1099, W-2G, 1099-INT, 1099-DIV)  
Total amounts of itemized deductions (charitable contributions, auto taxes paid, other property taxes, etc.)  
For direct deposit of refund, bank documents showing routing and account numbers.

Total amount paid for child or dependent care & providers ID or SS Number  
Settlement Statement from home purchase (For first-time homebuyers credit)  
Tax Year 2008 Federal and State Return, Tax Year 2009 tax package if one was received  
To file a “married filing joint” return electronically, both spouses must be present to sign forms.  
NO Returns requiring a Schedule C will be prepared
